Canadians are now waking up to the fact that significant numbers of physicians who were also forced to be injected have since suffered long term injuries and even death in ways that match cases that have been investigated and were demonstrated to be caused by parts of the Covid vaccine products. These groups exist partly because the fight to combat mainstream media censors, along with the power of the "disinformation gurus", are often too strenuous for medical professionals to face alone.
