Re: Immediate suspension of COVID-19 Vaccines in children of all ages, in Alberta

Dear MLA (NAME)

I am writing in support of Dr. William Makis' call for the immediate suspension of COVID-19 Vaccines in children of all ages in Alberta. Attached, you will see the letter that was directed by Dr. Makis to both the Premier and the Minister of Health. Dr. Makis has been tracking the devastating effects that the various aspects of the COVID-19 injections have had on children and teens, including on Alberta children. Here are some additional facts that speak against the use of these injections.

- The COVID-19 virus makes its way into the body's tissues by attaching to velcro-like ACE-2 receptors on various cells. However, these receptors are not yet developed in children, so if the virus enters the body, it virtually passes through without finding places to adhere. This is why no healthy children died of COVID-19 in Alberta prior to the rollout of the shots.
- The COVID-19 injections are packed with **trillions** of nano-sized **fat particles** that encase packets of **mRNA blueprints** for the making of the spike protein of the SARS-CoV-2 virus. **Trillions** means an utter bombardment of the body with foreign particles that the immune system needs to fight. With every shot or booster, it takes a while for the body to remake its stock of depleted immune cells, just like it take an army time to recruit more soldiers after a major battle in which the losses are heavy. This is why there was such a large wave of RSV in children after the vaccines were

first made available to the younger demographics. Their defences were DOWN for quite some time. Studies now show that the more often someone receives an injection of trillions of these mRNA instructions, the less able the immune system is to rebound quickly, leaving the body's defences down for increasingly longer periods of time. That is how hospitals were overstretched with a "pandemic of the vaccinated" although it was not openly reported as such. **Fat particles** (aka lipid nanoparticles) means that the encasement of the mRNA blueprints can slip through the barriers that the body has naturally developed, like the blood brain barrier, or in the case of a pregnant women, the placental barrier. This type of fat particle was originally developed to slip brain cancer medication into the brain where it was supposed to do some good. But in the case of C-19 shots, that medication was replaced with the **blueprints** to build spike protein, which was shown already in 2021 to be the single component of the SARS-CoV-2 virus that was responsible for most of the damage.

- What was lost on well-intentioned but ill-informed public policy makers was that when trillions of cells within the body are commandeered to build a foreign protein, the body's immune cells not only kill off the foreign protein but they also attack the body cells that are still holding on to the product they just made. Also not reported is the heavy presence of vaccine-induced spike protein found in key organs of the deceased by pathologists using a special staining procedure not allowed in Canada. Additionally not widely reported, was Health Canada's admission that they were aware of DNA and other contaminants in the end product leading to faulty, misfolded and unknown proteins also being made within the body with unforeseen potential consequences. When Canadian and international researchers tried to warn the world of these various facts, they were shut down and often removed from their publication platforms and their jobs.

We need to recognize that every time children are injected with a product to potentially prevent infection from a disease that is not a great risk to them, they are at increased risk for potential system-wide internal damage. Some of that damage progresses very rapidly while some is only slow to progress and manifest itself. We need open discussion around the next steps—for the prevention of more cases of vaccine-related damage, for diagnosis of this damage and for the recognition of treatment of this vaccine induced damage. Staff in so-called "Long Covid Clinics" are woefully unaware of treatment protocols for the various constellations of symptoms that arise in people affected by the spike protein in the virus and generated by the vaccine. And pharmacists faced with the choice of injecting harmful products to clients or losing their jobs for non-compliance also need our help. Having the government follow the lead of the many jurisdictions who have long stopped victimizing their youth with the injections is long overdue.

Just like as per a CBC report from April 5, Montreal public health officials recently warned people about the presence and danger of counterfeit hydromorphone pills after ONE death, so is it incumbent on Alberta public health officials to warn the public of the dangers of the COVID-19 vaccine “in name only” - a product that does NOT prevent transmission, or infection or provide robust, long lasting immunity as vaccines have long been known to do. Instead, a product that has been implicated as the cause for at least 17 million deaths world wide, as per Canadian interdisciplinary scientist Dr. Denis Rancourt and his team.

Please share the letter from Dr. Makis along with the information in this letter with your colleagues on both sides of the Legislature and push for immediate action. The future health of our children is not to be treated as a partisan matter. Stop the Shots in Kids and Teens now!
